It is proposed to call for application from the qualified employees of Board, who have passed B.E.(Mechanical) (only part time (or) Regular) or equivalent or Section A and B of AMIE Examination as referred to in Regulation 94 Annexure-III for consideration and appointment to the post of Assistant Engineer/Mechanical by Internal Selection.

2) The employees working in Regular work establishment and Provincial Cadres who are in possession of the above said qualification are eligible for consideration for this selection and appointment as Assistant Engineer/Mechanical and acquiring B.E. degree through Distance Education from any Universities are not eligible for consideration and appointment to the post of Assistant Engineer/Mechanical by Internal Selection.

3) TANGEDCO has filed appeal before the Supreme Court of India for challenging the direction of the High Court of Madras in W.A.Nos. 123 & 124/2010 filed by Thiru B. Krishna Kumar and Thiru M. Rajiv Suresh regarding acquiring M.E. / M.Tech. degree without basic qualification of B.E. Degree employees are not eligible for consideration and appointment to the post of Assistant Engineer/Electrical by Internal Selection. The above case is still pending in the Supreme Court of India.

4) The minimum period of one year regular service is essential after passing the required qualification for eligibility to apply to the post of Assistant Engineer/Mechanical who belongs to OC,BC,MBC/DC has since been cancelled in the reference (2) cited.

5) Those who are qualified and willing should submit their applications in the prescribed form (specimen of which is enclosed) to their Head of Office on or before **29.2.2012**, and those who do not apply, before the above said date, will not be considered for selection.
