The channels of promotion to the post of Junior Engineer Grade-II (Electrical) was discussed with the Trade Unions during the year 1987 and Boards' proceedings was passed vide ref (2) cited above.

From the year 1987 to 2000 there was no dispute in the promotions of Junior Engineer Grade-II. During 2000 few individuals misunderstood the Board's Proceedings and litigated in the Court.

During 2010, before the hearings of the Hon'ble Single Judge, Board's counsel has not presented the facts properly, in fact presented wrong information, to the court which resulted in quashing of the Boards' proceedings (B.P.17 Dt.05.07.2003) cited in the ref(3). In fact B.P.17, Dt.05.07.2003 is nothing but the amendment to the Service Regulation for the B.P.33 Dt.04.04.1987.

There by, the well settled channel for the promotions of Junior Engineer Grade-II between Diploma Engineers and Non-Diploma Holders which was in practice for more than 33 years was disrupted.

We T.N.E.B. Engineers' Sangam and the Board have filed Writ Appeals before the Division Bench of High Court of Madras defending the Boards proceedings and the well established channel of promotion for the post of Junior Engineer Grade-II. The cases were listed for hearing on many dates but could not see the result.


On 07.10.2014 when the matter came up for hearing Board's Counsel was not present and the junior informed the Court that AAG (Additional Advocate General) has to appear for the case and requested postponement. In earlier occasions also such a request was placed before the court.

The Hon'ble Judges not accepted the request, however posted matter after eight weeks.

The Writ Appeals are expected to come for hearing on 07.01.2015. The promotion panel from the post of Technical Assistant to Junior Engineer Grade-II is pending for years together and the individuals in the panel are frustrated because of the abnormal delay.

Hence, we request the Chairman cum Managing Director to kindly direct the authorities concerned to get the appointment of the AAG for his presence on the date of hearing of the cases to clear the legal hurdles.
