Sub: Promotion to the post of Junior Engineer Grade-I (Electrical) from Junior Engineer Grade-II – interim order closed – No Legar Bar in the promotion of Junior Engineer Grade-I – urgent action requested – Reg.

Few individuals, whose seniority in the Junior Engineer Grade-II / Electrical is to be decided by the Writ Appeal pending before the Hon'ble Division Bench of Madras High Court, have filed writ petition challenging the promotions of Junior Engineer Grade-I (Electrical).

On 05.11.2014 when the group of cases came up for hearing, we have presented that;

- i) The petitioners seniority is pending to be decided by the Writ Appeal and at this stage they are not entitled for further promotion as Junior Engineer Grade-I.
- More than 390 vacancies exists in Junior Engineer Grade-I category and the promotions to our members in Junior Engineer Grade-II are getting delayed by the interim orders in the case and requested to vacate the interim order (or)

to reserve posts for the petitioners and allow the Board to process the promotions.

After hearing the arguments the Court passed order to;

- Post the Writ Petitions along with the Writ Appeal pending before the Hon'ble Division Bench of Madras High Court.
- Interim order of status quo already granted is extended for a period of one week.

The period of one week (i.e. from 05.11.2014 to 12.11.2014) has passed and as on date there is no legal bar in the promotions of Junior Engineer Grade-I (Electrical).

Hence, we request the Chairman cum Managing Director to kindly order to process the D.P.C. meeting for the promotions of Junior Engineer Grade-I (Electrical) and issue the promotion orders immediately.
