
With reference to the above, the panel for the post of Superintending Engineer (Electrical) was approved for 47 persons and promotions were issued according to the vacancies available in the post.

PROCEEDINGS:-

Under regulation 92 of the Tamil Nadu Electricity Board Service Regulations read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme, 2010, Thiru S.Balasubramanian, Executive Engineer/Operation/Thirukkanoorpatty/ Thanjavur Electricity Distribution Circle, is regularly promoted and posted as SuperIntending Engineer/Electrical, in Class-I (Division-III, Category-I) of Tamil Nadu Generation and Distribution Corporation Limited Service with effect from the date of assumption of charge.

2. Thiru S.Balasubramanian, Executive Engineer/Operation/Thirukkanoorpatty/ Thanjavur Electricity Distribution Circle, on promotion, is posted as SuperIntending Engineer/Karur Electricity Distribution Circle, in the existing vacancy.
