Under the circumstances explained by the Chief Engineer (Distribution)/ Erode Region, sanction is hereby accorded for formation of new Division at Edappady by bifurcating the Mettur Division in Mettur Electricity Distribution Circle. Also, the existing AEE/ Sankari/ C&I be redeployed from Sankari Division to Omalur Division as **Kadayampatty C&I Sub-Division**. The existing Revenue Branch and Sub-Stores at Mettur Division be utilised in both Mettur and Edappady Division.
