Sub: TANGEDCO – Trichy region and Villupuram Region – Extensive damage to the electrical distribution network of Cuddalore EDC and Nagapattinam EDC due to heavy wind and rains from 9th Nov 2015 - Staff deputed from other circles for quick restoration of supply - Provision of snacks, Triple wages for the workmen – Approval requested by CE/D/Trichy and CE/D/Villupuram – Approval accorded.

In the above references (1) & (2), CE/D/Trichy and CE/D/ Villupuram dt.13.11.15 have stated the following:

Extensive damages were caused to the electrical distribution network of Nagai EDC and Cuddalore EDC due to heavy wind and rains from 9th Nov 2015. Major HT/LT lines, transformers and other substation equipments have got damaged. For restoration of supply, officers and staffs from other Circles were deputed on short notice due to emergency nature of work. The works for restoration of supply have been carried out from 9th November 2015 onwards in extraordinary weather conditions.

1. Total persons (officers & staff) deployed is 2350 Nos. from various circles of other Regions and Villupuram Regions for restoration works in Cuddalore EDC were engaged for seven days and the total mandays works out to 16450 mandays.
2. Total persons (officers & staff) deployed is 348 Nos. from various circles of Trichy Region for restoration works in Nagapattinam EDC were engaged for seven days and the total mandays works out to 2192 mandays.
3. The above rectification works were carried out without break round the clock in extreme weather conditions with pouring rain.

The CE/D/Trichy and CE/D/Villupuram have requested approval for the following:

- (i) Pocket expenses Rs.100/day/person.
- (ii) Triple wages to officers and staff deployed for rectification works.

In addition to the above, CE/D/Villupuram has requested wages for 20 contract persons at Rs.750/per/persons for rectification works and hiring charges for one mini lorry.

4. As these works are essentially required for restoration of supply on war footing basis, the request of CEs/D/Trichy & Villupuram Regions has been considered and approved as a special case by the CMD/TANGEDCO as per powers delegated in TANGEDCO proceedings: (FB) No. 71dt.29.06.2011: Delegation of powers of sanction to officers (TNEB Volume-II) vide item No.25 Miscellaneous.

5. For the triple wages, the full payment/adhoc payment may be made to the officers/staff on the last day and the amount can be regularized by claiming TA Bills.

6. The Chief Engineer/Trichy and Villupuram are requested to ensure proper completion of restoration works and justify the payments in each case separately by regularizing the works executed in view of urgency.
