

I am directed to enclose a copy of the reference cited and to inform that the Election Commission of India, New Delhi, in its letter dt. 21.05.2016, has stated that the operation of the Model Code of Conduct has come to an end with immediate effect in Tamil Nadu except in the two Assembly Constituencies of Tamil Nadu, where the poll has been postponed and in the Districts in which the two Assembly Constituencies (134.Aravakurichi Assembly Constituency - Karur District and 174. Thanjavur Assembly Constituency - Thanjavur District) are comprised in as per the existing guidelines of the Commission.

2. The said instructions in the enclosure is to be brought to the notice of all Head of Departments and all other officials under your control. Strict adherence of Model Code of Conduct may be followed for the above two constituencies and the districts concerned.


