Sir,

Sub: Recruitment (Internal) - Class II Service - Filling up of Vacancies of AE/Civil by Internal Selection -proposals of qualified employees - Called for.

\*\*\*\*\*

It is proposed to call for application from the qualified employees of TANGEDCO/TANTRANSCO to fill up 25 vacant post of Assistant Engineer/Civil by Internal Selection as per ratio 1:1.

2) The eligibility conditions are as follows:-

- i) The employees who are working in Regular work establishment and Provincial Cadres who are drawing the regular time scale of pay.
- ii) The employees who have passed B.E.(Civil) (only part time (or) Regular) or equivalent or Section A and B of AMIE Examination as referred to in Regulation 94 Annexure-III.
- iii) The employees who have passed B.E. degree through Distance Education from any Universities **are not eligible** for Internal Selection.
- iv) As per Regulation 95(b) of TNEB Service Regulations the employees who are approved probationer or probationer are eligible to apply.
- v) The employees who are involved D.P/ undergoing punishment on the date of notification are not eligible.

3) The TANGEDCO has filed appeal before the Supreme Court of India for challenging the direction of the High Court of Madras in W.A.Nos. 123 & 124/2010 filed by Thiru. B.Krishna Kumar and Thiru. M. Rajiv Suresh regarding acquiring M.E. / M.Tech. degree without basic qualification of B.E. Degree employees **are not eligible** for consideration and appointment to the post of Assistant Engineer/Electrical by Internal Selection. The above case is still pending in the Court.

4) The selection will be made on merit according to the rule of reservation order as per G.O.Ms.No.65, P & AR (K) Department dt.27.05.2009 and as per Regulation 95b of TNEB Service Regulation.

5) I am to request you to communicate this reference to the subordinate officers with suitable instructions to give wide publicity by displaying this communication on the Notice Board of their respective offices.

6) If any acquired B.E. degree through Distance Education from any Universities proposals are sent to this office, it will be viewed serious and action will be taken on the concerned Staff/ Officer, in this regard.

7) Those who are qualified and willing should submit their applications in the prescribed form (specimen of which is enclosed) to their Circle Head of Office on or before **18.08.2017**, and those who do not apply, before the above said date, will not be considered for selection.

8) I am to request you to obtain the applications from the employees with attested copies of certificates, if any by fixing a last date for receipt of application and on forwarding of application, necessary genuineness certificate has to be obtained from the concerned University for the B.E/B.Tech./AMIE degree qualification. The appointment order shall be issued to the selected employees only after receipt of the genuineness certificate. The Bio-data of the employees furnished in their applications and original degree and other certificates may be thoroughly verified and a consolidated proposal in Annexure-A may be sent along with their applications.

9) I am also to request you to forward the consolidated proposal furnishing all the required details in complete shape, in Annexure-A so as to reach this office positively before **06.09.2017** without fail.

10) If no qualified person is available, a NIL report should be sent promptly.

11) This should be treated as specially urgent and the reports sent to this office within the specified date.

12) The application format, Declaration and Annexure-A are enclosed.

13) I am to request you to acknowledge receipt of this letter.
