PROCEEDINGS:-

The TANGEDCO has created 11 nos. of Assistant Engineers/Junior Engineer-I Grade posts vide B.P. second cited (i.e.) two post each for in Chennai Region/North and South and seven nos. posts for Regional Offices for implementation of computerized LT Billing System under Project BEST. Likewise Geographical Information System (GIS) technology has been utilized in TANGEDCO for mapping of all the asset and consumer information in digital platform with an in house team of Assistant Engineer/Assistant Executive Engineer/GIS Officers at EDC, Distribution Regions and GIS Division at Headquarters. The said officials were trained through various programmes conducted by the GISs.

2. Considering the nature of work and the request of Chief Engineers sanction is hereby accorded for upgradation of Assistant Engineer/Project BEST posts in the Level of pay of Rs.39,800-1,26,500/- in all Regional Offices (i.e. two posts each in Chennai Region/South and Chennai Region/North and each one post in other seven regions) as Assistant Executive Engineer/Project BEST in the Level of Pay of Rs.58,200-1,84,300/- on their promotion so as to utilize their services beneficially to the Board.

3. Sanction is also hereby accorded for upgradation of the existing posts of Assistant Engineer/GIS in the Level of Pay of Rs.39,800-1,26,500/- in Regional/Distribution Circles and Headquarters as Assistant Executive Engineer/GIS in the Level of pay of Rs.58,200-1,84,300/-. The incumbent of the post shall be retained in the same stations on promotion.

4. The upgraded posts mentioned in paras-2 & 3 above shall get downgraded as Assistant Engineer/Junior Engineer-I Grade/Project BEST and Assistant Engineer/Junior Engineer-I Grade/GIS from the date of which the present incumbents of the posts gets relieved/retired.

5. The incumbents of the posts ordered in paras-2 & 3 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.

6. The expenditure is debitable to "TANGEDCO Funds – Revenue Expenses – 75 – Employees costs 75.1 – Salaries – 75.110 – Salaries Provincial".
