Sub: TANGEDCO – NHIS 2016 – Sanction of Medical expenses to the employees consequent to Departmental Electrical/ Mechanical Accident – Availing of cashless facilities under NHIS-16 - Certain instructions - Issued.

In the reference first cited, orders have been issued to the effect that in case of accident to the employees/officers of the Tamil Nadu Generation and Distribution Corporation Ltd and Tamil Nadu Transmission Corporation suffer injury due to accident while performing his duties or while travelling from his residence to office to perform the duty or while returning from office to his residence after performing his duty, the entire cost of medical treatment incurred by the employees/officers of TANGEDCO and TANTRANSCO be reimbursed by the Corporation without any reduction.

2. In the reference second and third cited, certain instructions have been issued in connection with the above orders. In the reference fourth cited among others, instruction have been issued directing to submit the bills for reimbursement in respect of Departmental/ Road accidents covered with proper scrutiny as per the check list issued vide reference third cited within three months from the date of discharge from the Hospital. In spite of the above instructions, the proposals are received from various Chief Engineers/Superintending Engineers with a delay of more than a year and which are also not in complete shape. In most of the cases, the proposal are returned with a direction to re-submit the proposal along with the documents as mentioned in the reference third cited which causes much hardship and delay in reimbursing the actual medical expenses to the affected employees. Similarly in the reference fifth cited, Nodal Officers and Co-Ordinator have been appointed to assist the employees in availing cashless facilities under the NHIS through M/s.United India Insurance Co.Ltd.

3. Considering the above, all the Chief Engineers/Superintending Engineers are hereby requested to adhere to the instructions issued in the references cited and forward the proposals relating to Departmental Electrical/Mechanical/Road Accidents within three months from the date of discharge, for sanction of reimbursement amount to the affected employees along with the documents/particulars mentioned therein. Further they are also requested to avail the eligible amount sanctioned by the United India Insurance Company Ltd. / MD India Health Care (P) Ltd in the first instance and then claim the medical expenses over and above the Insurance from TANGEDCO in the case of Departmental accidents and the Hospital & Disease are covered under NHIS-2016. Further if any difficulties arises, they may contact the Nodal officer/ Co-Ordinator immediately as mentioned below for the purpose of any clarification/difficulties in availing the cashless facilities under NHIS-16/ Covid-19.
