2. They are directed to join duty to the officer noted against them in each in Column No. 7 after getting proper relief from the present station within 15 days from the date on receipt of this order.

3. In the promotion orders, it may be indicated that if they do not join duty within the stipulated time, their promotion is liable for cancellation.

4. The Executive Engineers are informed to issue orders declaring completion of probation in the post of Junior Engineer / Electrical II Grade to the individual, to whom orders of declaration of completion of probation have not been issued so far and then serve the promotion and posting orders.

5. The Executive Engineers are informed to report the date of relief and joining of the individual.

6. They are also informed that their pay may be fixed under Service Regulation 33 (b) or as per their option exercised subject to admissibility as per existing rules.

7. The promotees are informed that the promotion order is subject to the outcome of the verdict in the W.P. (MD) No. 26597, 26056, 26053, 26678, 26676 / 2019 and Contempt Petitions in Cont. Pet. (MD) No. 1315, 1684/2019 and other Writ Petitions filed if any pending in the Hon'ble High Court.

8. The Executive Engineers are also informed to issue suitable instructions to the officers concerned to relieve the officials within two weeks from the date of issue of appointment and posting orders without waiting for joining of substitute.

9. The Executive Engineers are further informed that the promotees may be informed that their representation for modification of the orders will not be entertained and if they fail to join duty within 10 days from the date of relief and necessary action will be taken to cancel the appointment orders.

An option form is enclosed they are directed to submit the option form duly filled up within one month from the date of their joining as Junior Engineer I Grade. They are also informed that if the option is not submitted within the above said period of one month their pay the post of Junior Engineer I Grade will be fixed as specified in Para 3 of Boards Sec. Br. Memo. No. 75405 / P1 / 90 - 1, dt. 19.03.1991.
