powers of the CE/System Operation and SE/Operation. The AEEs and AEs/ Maintenance of the respective Substation will execute and supervise and process the bill for making payment.

By virtue of the provisions contained in sub-section (2) (a) of section 185 of the Electricity Act, 2003, the TANTRANSCO being the Transmission utility, Licensee and successor entity of Tamil Nadu Electricity Board will exercise the powers of the Telegraph Authority under the provisions of section 164 of the Electricity Act, 2003, which have already been conferred upon the Board under section 51 of the Indian Electricity Act, 1910.
