It is to inform you that the following candidates are posted to your circle as per annexure enclosed herewith.

2) The candidates mentioned in the Annexure is appointed as Assistant Engineer/Electrical (Trainee) subject to the following conditions.

- (i) He/She should produce satisfactory records in original relating to his /her educational qualification, date of birth, Community etc., before joining duty. If any discrepancy is found to unqualify for the post now offered, his/her selection and appointment shall be cancelled.
- (ii) Candidate should produce the undertaking in Rs.100/-Stamp paper along with the certificate of Physical Fitness obtained from a Medical Officer not lower in rank than that of <u>a Civil Surgeon</u>. In case of differently abled persons, relevant certificates may also be verified.
- (iii) If he/she is employed, he/she should get proper relief from present employer before joining the services of TANGEDCO.

3) The Form of Physical Fitness Certificate was already been sent to the selected candidates. The Physical Fitness Certificate produced by the candidates may be requested to be verified by the competent authority based on the guidelines issued in Adm. Branch Memo No.134/730/ R.II(1)/85-1, dt.20.12.1995 (Published in TNEB Gazette) and defective Certificates may be returned to the candidates for rectification of the defects by the Medical Officer who issued the certificate with his dated attestation.

4) The selected candidates should work in their allotted place until completion of five years and shall not be eligible to make any application requesting transfer to any other circle/office under the control of any other appointing authority and, until completion of three years, shall not be eligible to make such application within the circle/office under the control of the same appointing authority as per orders issued in (Per.) (CMD) TANGEDCO Proceedings No.7 (Adm. Branch), dated 08.03.2019.

5) The selected candidates should be informed that the appointment order has been issued as Assistant Engineer/Electrical under the services of TANGEDCO will be subject to the outcome of the final orders in the (High Court of Madras and Hon'ble Madurai Bench of Madras High Court) in the W.P.Nos.1174 to 1176/2000, W.P.No.18012/2008, W.P.No.18634/2013, W.A.Nos.235 and 267 of 2017, W.P.(MD) No. 4119 of 2017, W.P.No.6564 of 2017, W.P.(MD) No.4233 of 2019, W.P.(MD) No.203 of 2019 etc.

6) The candidates who do not possess adequate knowledge in Tamil after joining may immediately be directed to pass second language test within the period as per Service Regulations and entry to that effect may be made in the Service book of the individuals.

7) The selected candidates may be appointed in the level 5 of pay matrix for Officers at Rs.39800-126500/- for a period of 3 months. After the successful completion of training, the candidates may be appointed as Assistant Engineer/Electrical on probation for two years.

8) Necessary Genuineness Certificates of the candidates have to be obtained from the concerned Educational Department for the Educational Qualification.

9) Genuineness of the Community certificate, priority certificates shall be obtained from the issuing authority.

10) The Superintending Engineer concerned is informed that a thorough check may be made on the records presented by him/her at the time of joining and discrepancy if any is found, the candidate may not be served orders and may not be permitted to join duty and the same may be intimated to the Chief Engineer/ Personnel promptly without delay.
