PROCEEDINGS:-

In the Proceedings read above, Thiru A.Subramanian, Assistant Executive Engineer/Electrical has been included in the panel of Assistant Executive Engineers/Electrical fit for promotion as Executive Engineers/Electrical for the year 2018-2019 with ranking as Sl.No.24-A (Twenty four-A).

2. Consequent on the above, under regulation 92 of the Tamil Nadu Electricity Board Service Regulations read with Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010, Thiru A.Subramanian, Assistant Executive Engineers/Electrical/O&M/Keeramangalam/Pudukottai Electricity Distribution Circle is deemed to have been promoted and appointed as Executive Engineer/Electrical in category 3, Division-III Class-I of TNEB Service Regulations with effect from 08.03.2019 i.e. the date of joining of one of his junior Tmt.M.C.Kannagi as Executive Engineer/Electrical.

If so, necessary clarification may be obtained from the Secretary, before serving the said promotion order to the official concerned.

He is eligible for fixation of pay in the post of Executive Engineer/Electrical as per note-2 under regulation 37 of Tamil Nadu Electricity Board Service Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010.
