A point of clarification has arisen whether one sitting B.Com degree conducted by Osmania University is valid for sanction of increment and promotion.

2. The University Grants Commission has been consulted with regard to one sitting B.Com degree conducted by Osmania University is valid. The clarifications received from the above authority has been examined in detail and it has been decided that one sitting B.Com degree is not equivalent to regular three year B.Com degree.

3. Accordingly, it is hereby ordered that one sitting B.Com degree course conducted by Osmania University shall not be taken into account for grant of incentive increment/promotion.
