The Government, in its G.O. read above, among other things have issued orders on total ban on creation of new posts in all Departments, considering the prevailing situation of COVID-19 in the State and the compelling need to regulate expenditure on emoluments.

Accordingly, the TANGEDCO hereby ordered that there shall be a total ban on creation of new posts except those covered under work load settlement in TANGEDCO/TANTRANSCO, considering the prevailing situation of COVID-19 in the State and the compelling need to regulate expenditure on emoluments.
