**PROCEEDINGS:-**

Industrial visits by the students of Engineering Colleges to the vital installations in TANGEDCO/TANTRANSCO are permitted duly after getting prior permission from the Director General of Police/Vigilance/TANGEDCO. The number of colleges seeking permission for industrial visits has increased. At present, no fees/charges are being collected from these colleges for their Industrial visits. Therefore, the Director General of Police/Vigilance/TANGEDCO has proposed to collect a nominal fee of Rs.100/- plus applicable GST be levied for visiting the vital installations. The Chairman-cum-Managing Director/TANGEDCO has approved the proposal.

2. Accordingly, it is hereby ordered to collect a nominal fee of Rs.100/- (Rupees one hundred only) per student plus applicable GST from the students of Engineering Colleges to visit the vital installations of TANGEDCO/TANTRANSCO. The fees may be remitted by Demand Draft in favour of the concerned Superintending Engineer's (Account Head 62.980) by the college before the date of visit and the GST Accounts heads shall also be used towards recovery of GST rates.
