PROCEEDINGS:

The Chief Engineer (Distribution)/Erode Region has submitted a proposal for formation of a new O&M Division at Pallipalayam by bifurcating the existing Sankari Division and new Sub-Division at Veppadai in Mettur Electricity Distribution Circle so as to improve the administration in a better way which will help the public in greater manner.

2) The proposal of the Chief Engineer (Distribution)/Erode Region is examined in detail. The Board of TANGEDCO has approved for formation of new O&M Division at Pallipalayam by bifurcating the existing Sankari Division and new Sub-Division at Veppadai in Mettur Electricity Distribution Circle.
