PROCEEDINGS:-

The Board of TANGEDCO has accorded approval for sanction of 155 Nos. of Posts in various disciplines to 1x660 MW ETPS Expansion Project for a period of Four years (or) till the completion of the project. Accordingly, 108 posts in various disciplines were created vide reference first to eight and ten above.

2. Consequent on awarding of Project Management Consultancy contracts and as per the orders of the Board of TANGEDCO in its 91st Board Meeting held on 22.11.2019 the Director (Projects)/TANGEDCO has submitted the proposal to utilize minimum staff to carry out execution of the Project. Out of the 108 posts, at present 72 posts are utilized and 36 posts are vacant. In that 72 posts utilized, 13 posted officials are yet to join, 1 official

diverted to TANGEDCO Headquarters and 14 officials are diverted to NCTPP Stage-III for commissioning activities and the remaining staff strength is only 44 Nos. The Director/Project has further suggested to retain 7 Nos. of Posts, for ETPS Expansion Project and the remaining 37 Nos. Posts are to be utilized elsewhere. Further the diverted officials for commissioning purpose may be retained at NCTPP Stage-III after the unit is commissioned. The Chairman-cum-Managing Director/TANGEDCO has accorded approval to the proposal.
