PROCEEDINGS:

The Government, in its order read above, have issued amendment to rule 24-A of the Tamil Nadu Government Servants' Conduct Rules, 1973 exempting the Government Servants from obtaining No Objection Certificate, for proceeding on Jerusalem Pilgrimage through Government Schemes.

2. The Tamil Nadu Electricity Board Employees' Conduct Regulations have been framed based on the Tamil Nadu Government Servants' Conduct Rules, 1973. The regulation 27-A of TNEB Employees' Conduct Regulations is corresponding to rule 24-A of Tamil Nadu Government Servants' Conduct Rules, 1973. Hence, a proposal for making amendment to the said regulation based on the Government Order read above, was placed before the Board of TANGEDCO for its approval. After careful consideration, the Board has approved the said proposal.

3. Accordingly, in exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited (formerly Tamil Nadu Electricity Board) makes the following amendment to the Tamil Nadu Electricity Board Employees' Conduct Regulations.

AMENDMENT

In the said Regulations, in regulation 27-A, after the second proviso, the following proviso shall be added, namely:

"Provided also that the employees proceeding on Jerusalem Pilgrimage through Government Schemes are exempted from obtaining **"No Objection Certificate"**."

4. The above amendment shall be deemed to have come into force on 27th January, 2020, i.e. the date of issue of Notification as mentioned in the Government Order read above.
