Respected Sir,

Braving all these critical conditions our Engineers and Staff are putting up their full efforts in performing their official duties to ensure uninterrupted power supply to the public, hospitals and the industries. Even commuting during this strenuous period is quite arduous.

But we are pained to note and inform the Respected Chairman cum Managing Director that many of the Officers including few at Head Quarters, unmindful of the prevalent ambience are putting up more pressure on the field Engineers and Staff in completing the tasks related to schemes and improvement works. This has added mental agony to our Engineers, Staff and their families too.

Hence we request the kind intervention of the Respected Chairman cum Managing Director in this matter and instruct the officials concerned appropriately to

- Give top priority for preventive and breakdown works only.
- All works related to improvement, schemes, data collection ( like **Agriculture check reading, Load updation, Energy accounting, GIS survey....etc**) to be put on hold until restoration of normalcy.
- Extending the deadline of implementation of ERP for a minimum period of 3 months.
- Desist from conducting meetings and training programmes including online ones which are being conducted in a cramped space with more persons.

An earliest favorable instructions from the Respected Chairman cum Managing Director in this regard would be a great relief for the field Engineers and Staff to apply themselves wholeheartedly to ensure uninterrupted supply during this pandemic please.
