Considering the essential need and to revise certain tender powers of works contract under Tables VI and VII of Delegation of Powers of Tender Regulations 1991 upon taking into consideration the escalation of material cost, technology development, enhancement of Ease of Doing Business ecosystem, increase in labour charges and introduction of GST and the present scenario, a proposal has been placed before Board of TANGEDCO for enhancing the tender powers.
