Re-designation orders as Assistant Engineer / Mechanical had been issued for select Junior Engineer Grade-I / Mechanical who had completed B.E. Degree in Vinayaga Missions University citing the orders of the Hon'ble High Court, vide reference-1 cited.

We had represented earlier vide our representation cited under reference-2 that the said Re-designation orders as Assistant Engineer has not been issued to all the qualified Junior Engineer Grade-I individuals but only for the persons who had obtained orders from the Hon'ble High Court which is in violation of the norms, principles and practice followed all along in the Board.

Any Court order obtained on principle or policy has been applied to all concerned in that matter rather than select individuals who had got direction from the Hon'ble High Court.

Hence we had requested the Chief Engineer / Personnel to consider the application of the pending eligible Junior Engineer Grade-I / Mechanical, Junior Engineer Grade-I / Electrical and Junior Engineer Grade-I / Civil persons also and issue Re-designation orders as Assistant Engineer. The matter is still pending consideration.

We once again remind this matter to the Chief Engineer / Personnel for necessary consideration without further delay and issue Re-designation orders as Assistant Engineer for all the eligible Junior Engineer Grade-I in Mechanical, Electrical and Civil disciplines in line with the already issued orders cited under reference-1, please.

Assistant Engineer / Electrical promotions by internal selection was issued to 277 persons vide reference - 1 cited above. Persons who had completed Bachelor's Degree in Engineering had applied for this Assistant Engineer post. But in that promotion list, some of the persons who had qualified through Vinayaga Missions University, Salem and Periyar Maniammai University, Vallam had been left out.

Having learnt from the Personnel Management that the promotions to these persons had been kept on hold due to lack of clarity in certain credentials of the Universities concerned, we reminded that Assistant Engineer Promotions had been issued for similar cases all along in the previous years and hence represented to do the same in the current batch also.

After much insistence Board had requested clarification from UGC on the Universities concerned and got reply in this matter. It's almost quite long since then and the matter is still kept idle despite receipt of clarification from UGC in this regard. Numerous representations from the individuals and our Sangam had gone unheeded which is worrying. The promotions to the concerned individuals has been kept on hold for almost a couple of years which isn't quite justifiable.

Presently we learn that AICTE has sent a letter to our Board Secretary vide reference - 4 cited above which clearly states that prior to 2017 it is not mandatory for Deemed to be Universities to take AICTE approval for conducting Technical courses. The persons overlooked for Assistant Engineer promotions fall under this category and are eligible for their legitimate promotions.

Hence to do justice in the matter, we sincerely request the Chief Engineer / Personnel to take adequate steps immediately to resolve this matter and issue;

- · Assistant Engineer promotions to all the eligible left out persons and
- Issue re-designation orders as Assistant Engineers for those left out persons, who had been promoted as Junior Engineer / I Grade during this intermittent period without delay, at the earliest please.
