The Superintending Engineers concerned are requested to issue appointment orders to them as **Technical Assistant/Electrical** early.

- 2. In the appointment orders, it may be indicated specifically that the appointment is subject to the following conditions:
 - i) They should produce satisfactory records in original regarding their educational qualification and date of birth to the THEMSELVES before joining duty. If any discrepancy is found in the certificate or if they are found to be unqualified for the post now offered with reference to the certificate produced by them, their appointment will be cancelled.
 - ii) They should produce a certificate of Physical Fitness in the prescribed form.
- 3. A form of certificate of Physical Fitness should be sent to the candidate along with appointment order with suitable instructions to obtain the same from Government Medical officer with reference to the guidelines already issued in Para-6 of this Branch Circular Memo. No.126590/1750/CC1/81-1 dated 26.02.1982.

- 4. The dependant should be asked to produce the declaration (enclosed) in person on a date to be specified along with original certificates relating to their educational qualification and date of birth. All the original certificates should be recognized and checked. Only the certificates relating to educational qualification issued by the educational institution recognized by the Government is valid. The appointing authority may be requested that before issuing appointment orders, the educational qualification certificate produced by the applicant should be got verified. Orders of appointment should be issued only after the appointing authority has fully satisfied themselves that the dependant is qualified and eligible for appointment.
- 5. The concerned Superintending Engineer are also requested to obtain an undertaking in Rs.100/- Non-Judicial Stamp Paper duly attested by a Notary Public as instructed in the Adm. Branch's circular Memo No.093419/G9/ G91/2016-1, dated 19.11.2016 before issuing the appointment order to the individual selected on Compassionate Grounds and also all the other particulars may be collected as per the circular dated 19.11.2016.
- 6. The concerned Superintending Engineer are requested to follow the instruction issued in (per).FB TANGEDGO PROCEEDINGS NO.42, (Sectt.Br.) dated.28.11.2019.
- 7. The concerned Superintending Engineer are instructed to selected persons that until completion of five years, shall not be eligible to make any application requesting transfer to any other circle/office under the control of any other appointing authority and, until completion of three years, shall not be eligible to make such application within the circle / office under the control of the same appointing authority as per orders issued in (Per.) (CMD) TANGEDCO Proceedings NO.7 (Adm.Branch), dated 08.03.2019.
- 8. The concerned Superintending Engineers are requested to instruct the employees that the individual should join duty within 30 days from the date of receipt of the appointment order, failing which it will be construed that they are not interested to accept the appointment and further action will be taken to cancel their appointment orders and the employees may be informed that no representation for change of posting or extension of time to join duty will be entertained.
- 9. The copy of appointment order issued to the individual may be sent to this office and the date of joining reported promptly.
