PROCEEDINGS:

In the Government Orders read above, among other things orders have been issued that the voluntary contribution of one day's salary of the Government Employees and Teachers to the Chief Minister's Public Relief Fund towards the relief and rehabilitation measures being taken to curb the COVID-19 by the Government of Tamil Nadu. In this regard all the major unions have also expressed their willingness of their members to contribute their one day's salary to the Covid-19 Rehabilitation. Hence, the TANGEDCO has decided to adopt the above Government order.

2. All the pay drawing Officers are authorized to recover one day salary/more than one day salary on gross basis after obtaining the willingness of the employees/officials for the month of June 2021 by following procedure prescribed in Government Order read above followed to facilitate the contributions made by the employees of TANGEDCO, TANTRANSCO and TNEB Ltd.

3. The following instructions shall be followed by the pay drawing/disbursing officer while deducting one day wage or more than one day salary for the above Rehabilitation measures:-

- i. Any employee willing to voluntarily contribute One day's salary to the Chief Minister's Public Relief Fund towards the relief and rehabilitation measures being taken by the Government of Tamil Nadu to curb Covid-19 shall give his/her consent in writing to the concerned Drawing and Disbursing Officers.
- ii. The Drawing and Disbursing Officers shall make use of the provisions in the Web Pay roll application for calculating one day's/more than one day's salary in the pay bill for the month of June 2021.
- iii. Recovery shall be made straight from the Pay Bills and it shall be credited to head of Account Number viz 44.442 - Recoveries of contribution to the Covid-19 and the details of total amount recovered and credited to that account shall be intimated to the Deputy Financial Controller/Funds/Board Office Accounts Branch.
- iv. The Deputy Financial Controller/Funds, is directed to consolidate the details of recoveries made at the Circles and arrange to draw a cheque for the amount, towards the Relief Fund and to hand it over to the Government and the same shall be reported to the Secretary/TANGEDCO.
- v. The credit in Circles in Account No. 44.442 - Recoveries of contribution towards Covid-19 may be cleared by getting the debit advice to be raised by the Deputy Financial Controller/Funds through Cash Sections in Chief Financial Controller's office.
- vi. The Cash Section in Chief Financial Controller's office will raise the necessary debit advice after receipt of the details of recoveries made in each Circle and adjust against the payments made to the Fund (Account No.44.442 at Headquarters).
- vii. The drawing and disbursing officer shall also allow tax exemption to the extent of 100% on the contribution to Chief Minister's Public Relief Fund based on these orders. Employees who have contributed to Chief Minister's Public Relief Fund other than salary deduction may get receipt for such contribution from Chief Minister's Public Relief Fund to avail tax exemption.

- viii. Any employee willing to contribute more than one day's salary may also be permitted to do so as per the willingness given following the procedure mentioned under item (i) above. The Drawing and Disbursing Officers shall ensure that the contributions are made purely voluntarily.
4. The receipt of this proceedings shall be acknowledged.
