In the standard terms and conditions annexed to the Board's proceedings, it has been ordered that subscription shall be deducted from the pay bill for May payable in June every year.

- 2. In Memo (Per.) No.39962/A3/A31/2020-1, dt.18.11.2020 it was ordered to cancel the orders issued in (Per) B.P. (Ch) No.77 (SB) Dated:28.03.2007 & (Per) B.P. (Ch) No.111 (SB) Dated:09.05.2007 and dispense off with the practice of deduction of Subscription/ Donation from the member employees of registered Trade Union/Association. Further, in Memo (Per.) No.43915/A3/A31/2020-1, dt:04.02.2021, it has been ordered to deduct the Annual Subscription from Member employees and shall submit their willingness to the Controlling Officer/Pay disbursing Officer for the above deduction with the condition that an employee shall be permitted deduction of only one Membership fee.
- 3. Now, it has been requested for extension of time upto 15.08.2021 for exercising willingness for deduction of Annual subscription from the salary of the willing members due to COVID-19 Pandemic and also have the subscription deducted from the salary of August 2021 payable on September 2021, as a special case.
- 4. The request has been examined and accepted. Accordingly, it is hereby ordered that specific written authorization for deduction of Annual Subscription may also be accepted for the year 2021 upto 15.08.2021 and the Annual Subscription may be deducted as a special case from the pay for August 2021 payable in September 2021 due to COVID-19.
