- Sub: Estt. Class II Services JE/Electrical I Grade those completed B.E Degree in Vinayaga Missions University thro' Distance Education and requested to redesignate as AE/Electrical – Proposal called for.
- Ref: (i) Hon'ble Supreme Court order dated 03.11.2017 in SLP Nos.19807-19808 of 2012. dfsf
  (ii) Hon'ble High Court of Madras order dt.06.02.2020
  - in W.P.No.33033 of 2019 and W.M.P No.33461 of 2019.

I am to state that the Hon'ble Supreme Court delivered the judgement on 03.11.2017 pertaining to the degree that were granted by certain Deemed Universities wherein the part of the above Judgement is detailed below.:-

" The degrees of Candidates who enrolled during the academic sessions 2001-2005 will stand suspended, but they would be given an option to appear for tests to be conducted by AICTE and if they fail to clear the tests in not more than two chances the degree stand withdrawn"

If the students clear the test/tests within the stipulated time, all the advantages/benefits shall be restored to them and their degrees will stand revived fully. 2) Further in W.P.No.33033 of 2019 and W.M.P No.33461 of 2019 The Hon'ble High Court of Madras ordered on 06.02.2020:-

" In view of the above discussion, there shall be a direction to the 2<sup>nd</sup> respondent (CE/Personnel) to redesignate the petitioners as Assistant Engineers in accordance with the Service Regulations and consider their seniority from the year 2009 onwards and fit them accordingly, in the seniority list. Appropriate Orders shall be passed in this regard within a period of four weeks from the date of receipt of copy of this order.

This writ petition is allowed with the above directions. No costs. Consequently, the connected miscellaneous petition is closed".

3) Therefore, it is requested to send the proposals submitted by the individual which comes under the Court Orders (ie) who enrolled during the academic sessions 2001-2005 in Vinayaga Missions University and completed their degree Course thro' Distance Education and passed the special test conducted by the AICTE and requested to redesignate as AE/Electrical from JE I Grade to this office for necessary action.

4) Further it is requested to ensure all the details pertaining to the individual as enclosed in the profoma should be enclosed with the proposal since it is mandatory to take necessary action and avoid further delay in this regard.
