If any of the Diploma Holders of Draughtsman/Senior Draughtsman working in your circle possess Diploma in Electrical Engineering or equivalent qualification if they opt for considering for selection as Junior Engineer/ Electrical II Grade and their suitability reports may also be sent in the Format (2 copies) together with their year of passing Diploma in Electrical Engineering (copy of certificate to be furnished 2 copies) as required in the Format and submit their Undertaking 2 copies as detailed below:-

“I opt for appointment as Junior Engineer/ Electrical II Grade by Relinquishing my rights for promotion in Draughtsman cadre. By giving my option for such appointment, I realize that I shall not be entitled for further promotion in my former cadre of Draughtsman/Senior Draughtsman”
