Sub: TANGEDCO – Sanction of advance increment to the Board's Engineers who acquired P.G/Ph.D in Engineering – Orders Issued – Further instructions – Issued– Regarding.

In the reference first to sixth cited, orders were issued for sanction of advance incentive increments to Engineers of TANGEDCO for having acquired P.G degree and Ph.D in Engineering to the Board's Engineers upto and inclusive level of Executive Engineer.

2. In the reference seventh cited, cancelling the scheme of sanction of advance increment to the Board's Engineers upto the level of Executive Engineer who acquired P.G/Ph.D in Engineering in the orders issued in the reference first to sixth cited. In the said order among other things, if the Board's Engineers who have been sanctioned advance increment for having acquired P.G/Ph.D in Engineering through Deemed Universities without approval of the Competent Authority (Chairman cum Managing Director) and also studied through distance mode before 18.08.2012, the recognition of the Deemed Universities should be verified by the Secretariat Branch as per the existing orders.

3. It has been brought to the notice that most of the Board's Engineers have been sanctioned advance increment for having acquired P.G/Ph.D through Deemed-to-be Universities without approval of the Competent Authority (Chairman cum Managing Director). Hence, the following instructions are issued:-

- i. The orders issued in the (Per.) FB TANGEDCO Proceedings No.10 (SB) dated:23.03.2020 shall be implemented without any deviation.
- ii. The Chief Engineers/Superintending Engineers are directed to send all pending proposals seeking clarification/ratification/regularization in respect of P.G/Ph.D advance increment to the Secretary/TANGEDCO for sanction of incentive increment from the Competent Authority (i.e.,Chairman cum Managing Director) for due verification with University Grants Commission (UGC)/All India Council for Technical Education (AICTE) on case to case basis. The effect of advance incentive increment shall be made only on clearance received from the Secretary/TANGEDCO.
- iii. The Chief Engineers/Superintending Engineers have been instructed to ensure the genuineness of the degree with the Deemed-to-be Universities concerned before sanctioning of advance increment.


