- (3) It should be noted that all the Chief Engineers & the Superintending Engineers are to ensure the following details with regard to the above AE/Civil.
 - i) No past/ present details of the above AE/Civil exist under their control.
 - (ii) Details such as Joined / Not joined into Board's Service, Resigned / VRS / Medical Invalidation / Foreign Service / Unauthorized absence/ Dismissed / Removed from Board's service does not exists under their control.
 - (iii) Details of name change of the above AE/Civil does not exists under their control.
 - (iv) Details such as Expired / Pension / Family Pension details does not exists under their control.
- (4) It should be noted that, if any claim / discrepancy / legal litigations with regard to the above AE/Civil is received in future then action as deemed fit will be initiated on the official / staff concerned.

- (5) Hence, all the Chief Engineers & the Superintending Engineers are requested to bestow their personal attention in this regard and furnish the suitability report of the above AE/Civil as per the instructions issued in the letter cited under reference (3) without fail as the preparation of panel of Assistant Executive Engineer/Civil depends upon the receipt of the above report.
- (6) In addition to the above, the Performance Assessment Reports of the officials enclosed in the Annexure has also been not yet received in this office till date. In this regard, the Superintending Engineers concerned are informed that the following instructions have already been issued pertaining to the norms for writing up of the Performance Assessment Reports for Class I & II employees under reference 1 & 2^{nd} cited.
 - (i) The Reporting Officers to write Performance Assessment Report in time either with the self appraisal by the individual (or) without the self appraisal mentioning/recording the same.
 - (ii) The Reporting Officers shall ensure that the Performance Assessment Report of the employees of all categories under their control are written and submitted in time.
 - (iii) Responsibility will be fixed against the authority concerned on whose part the delay is attributable.
- (7) Therefore, it is requested to follow the above instructions and furnish the Performance Assessment Reports of the officials mentioned in Annexure to this office without fail on or before **24.09.2021**.
- (8) After the above said due date, Departmental Promotion Committee Meeting will be conducted without waiting for the particulars to be received. If any claim/discrepancy/legal litigations with regard to Thiru.RAJENDRAN. V (D.O.B.03-01-1967) and the officials mentioned in the Annexure is received in future, then Discipllinary Proceedings will be initiated against the official/staff responsible for not furnishing the particulars in time and for the undue delay caused for preparing panel works.
- (9) All the Chief Engineers & the Superintending Engineers should note that from the date of issue of call for letter seeking suitability report to till date of <u>issuance</u> of panel necessary updation if any to be made on the suitability report already furnished with regard to any individual should immediately/urgently be furnished to the concerned section (from whom the suitability reports have been called for) under the control of the Chief Engineer/Personnel.
