

Heeding to our persistent representations numerous promotions in various categories has been issued for which we wholeheartedly thank the administration. Few other promotions are under process and some of them couldn't be processed due to Court cases and other reasons.

Among the pending promotions, Junior Engineer / Electrical II Grade to Junior Engineer / Electrical I Grade promotions couldn't be processed despite huge backlog in the posts of Junior Engineer / Electrical I Grade, due to a stay in a case filed by a Non - Diploma individual in the Honourable High Court of Madras.

Our Sangam had impleaded in the above case and had vacated the stay. Hence calling for of particulars among the Junior Engineer / Electrical II Grade has to be initiated for Junior Engineer / Electrical I Grade promotions.

Hence we request the respected Chairman cum Managing Director to instruct the Chief Engineer / Personnel to initiate the Calling for process for Junior Engineer / Electrical I Grade promotions to fill up the backlog and thus render justice please.

Amendment to Service Regulations 94 and 98 of Tamilnadu Electricity Board Service Regulations were issued vide reference - 1 cited, increasing the length of service eligible for promotions breaking the six decade old practice.

This amendment to the regulations was issued in haste without considering the ground realities or practical applications in the field targeting few categories without following the procedure.

Our Sangam had continuously represented the administration to withdraw this order, vide our representations cited under references 2 to 5. Moreover during the detailed discussion held with our Sangam on 07.10.2021 our Sangam had emphasized the respected Chairman cum Managing Director on withdrawal of this orders citing its ill effects.

During that discussion respected Chairman cum Managing Director had assured us of withdrawal of the sinister amendment order cited under reference - 1. The assured matter is still on the anvil pending implementation.

Presently based on our representation and necessity to fill up large number of vacancies available in the post of Junior Engineer Gr-II (Electrical), the suitability report vide reference - 7 cited, has been called among 1077 Technical Assistants for promotion to the post of Junior Engineer / Electrical II Grade. Even though it looks like a hefty chunk of promotions for our Diploma Community, in reality only a meager number may be benefitted as major portion among the 1077 persons are ineligible due to this amendment cited under reference - 1.

Moreover huge number of vacancies exist in the post of Junior Engineer / Electrical II Grade in Generation circle and Substations affecting the Board's work to a greater extent.

Hence to benefit not just the individuals but the Board also, one time relaxation for the minimum service prescribed for promotion from Technical Assistant to Junior Engineer Gr II., as per the order cited under reference - 1 may be given for the present promotion panel called under reference - 7, to enlighten the lives of the affected individuals, thereby render justice please.
