In the reference first to fifth cited, orders have been issued for sanction of incentive increment to Board's Engineers for acquiring P.G/Ph.D degree in Engineering.

2. In the Board's Proceedings sixth cited, among others the scheme of sanction of advance increment to the Board's Engineers for having acquired P.G/Ph.D in Engineering has been cancelled/dispensed. Further, if the Board's Engineers who have been sanctioned advance increment for having acquired P.G/Ph.D in Engineering through Deemed Universities without approval of the Competent Authority (Chairman cum Managing Director) and also studied through distance mode before 18.08.2012, the recognition of the Deemed Universities should be verified by the Secretariat Branch.

3. In the reference eighth cited, instructions have been issued to the Chief Engineers/Superintending Engineers to send all pending proposals seeking clarification/ratification/regularization to the Secretary/ TANGEDCO for sanction of incentive increment by the Competent Authority (Chairman cum Managing Director) after due verification with University Grants Commission (UGC)/All India Council for Technical Education (AICTE) on case to case basis.

4. The period of courses studied by the Board's Engineers through Deemed-to-be-Universities and Government Universities have been verified by case to case basis with the website of University Grants Commission (UGC)/All India Council for Technical Education (AICTE).

5. After careful examination, the following orders are issued:-

- I. The total number of 57 candidates as mentioned in Annexure-I who have been sanctioned advance increment for passing PG Degree without the approval of the competent authority (i.e., Chairman cum Managing Director) have been verified along with the certificates and found correct. Therefore, the concerned Chief Engineers/ Superintending Engineers are hereby directed to allow them to draw their increments.
- II. The total number of 36 candidates as mentioned in Annexure-II who have not been sanctioned advance increments so far, for completing P.G Degree their certificates have been verified along with the University where the candidates have studied and completed their degree and found correct and therefore they are found eligible to get the advance increments. Hence, approval is hereby accorded to the concerned Chief Engineers/ Superintending Engineers for sanction of advance increments to the Board's Engineers for completion of their PG Degree from the day following the last date of examination/date of entry into Board's service.

- III. The total number of 10 candidates as mentioned in Annexure-III who have been sanctioned advance increments for passing PG Degree without approval of the competent authority (Chairman cum Managing Director) and objection raised by the Audit Branch. The above said candidates' certificates have been verified and found correct. Therefore, the concerned Superintending Engineer is directed to release the advance increments sanctioned to them from the date of their sanction.
- IV. The total number of 5 candidates as mentioned in Annexure-IV (2 candidates have completed PG Degree after 22.03.2020 and 3 candidates have completed PG Degree before 23.03.2020 but, joined in the post of Junior Engineer I Grade only after 22.03.2020) are not eligible for sanction of advance increments for completion of their PG Degree, since the scheme of sanction of advance increment for acquiring P.G/Ph.D in Engineering has been dispensed with from 23.03.2020. Therefore, the Superintending Engineers are directed not to sanction advance increments to them.
- V. The total number of 4 candidates as mentioned in Annexure-V have completed PG Degree which are not covered in the list of courses which are beneficial to the Board for grant of incentive increments. Therefore, the Superintending Engineers are directed not to sanction advance increments to them.
- VI. The Chief Engineers/Superintending Engineers may also be instructed to ensure before sanctioning/allowing the advance increment for PG/Ph.D Degree, that the conditions prescribed in para-4 (iii) of Memo. (Per) No.91974/A3/A32/2009-2, dated 07.10.2010 and para-4 (ii) of (Per) CMD TANGEDCO Proceedings No.198 (SB) dated:18.08.2012 have been followed.
- VII. The officials who have been appointed as Assistant Engineer on or after 23.03.2020 are not eligible for sanction of advance increments for completion of P.G/Ph.D in Engineering.
