Sub: Transfer of Engineers in Enforcement Wing – Board works and revenue will get affected – suggestive measures for reconsideration of transfer orders - represented regarding.

Administrative transfer orders has been operated for Assistant Executive Engineers and Assistant Engineers / Junior Engineers Grade I categories working in enforcement wing as per the references cited above.

We are totally shocked to see this exercise as it has been made without following the norms and procedure usually done while posting an Engineer in an Enforcement wing.

We would like to highlight the following points in this regard.

- Our Sangam is not against any transfers done on Administrative grounds carried out for the welfare of the Board.
- Yet we had raised our apprehensions numerous times against operating transfers to special areas such as MRT, GRT. P&C, Special Maintenance, Enforcement and other areas which needs experience and expertise.

Moreover we had requested exemption from transfer for these special areas as they don't come under the public contact (consumers).

- Shifting of experienced persons in enforcement wing and replacing them with others would totally stall the works in the wing as it requires more expertise and application rather than Knowledge and Technical skills.
- Normally the procedure adopted for posting an Engineer in Enforcement wing is quite meticulous as all details pertaining to the individual is analyzed by various officials before posting.

We fear that this procedure wasn't followed in this transfer leaving the very purpose of the Enforcement wing being defeated; Board's revenue will take a dent due to these transfers.

Hence we invite the attention of the respected Chairman cum Managing Director in this matter praying to do the needful for making the Enforcement wing function effectively as ever for the betterment of the Board please.
