PROCEEDINGS:-

In the reference first read above, the Director (Operation)/TANTRANSCO has proposed for formation of separate stores wing with supporting staff to have an effective control of stores transaction exclusively for the Operation Circle activities since the existing arrangements of stores transaction of Operation Circles are entirely managed by EDCs of TANGEDCO and it involves inter company transactions that hampers the reconciliation of accounts etc.

2. The proposal of the Director (Operation)/TANTRANSCO has been examined in detail. In the workload settlement between the Workmen and the Management of the TANGEDCO, in the Proceedings No.B2/386/2018 dated 22.02.2018 among other things, it has been agreed to form one Sub-Stores for each operation circle where GCC stores is not existing and orders have been issued in the proceedings second read above. Hence, it has been decided to accept the proposal of the Director (Operation)/TANTRANSCO and to redeploy the existing two Sub-Stores at Thanjavur and Virudhachalam. under the control of GCC/Trichy to the Operation Circles at Tiruvalam and Villupuram.

Accordingly, it is hereby ordered that two Sub-Stores be formed at Tiruvalam and Villupuram. Further, the posts last continued in the Memorandum third read above, be re-deployed along with the incumbent to the Offices. The details are as follows :-
