Proceedings

In the proceedings first read above, orders were issued fixing the monthly ceiling limit in respect of mobile network charges to all the officials, staff and Fuse off call Centres of TANGEDCO, TANTRANSCO and TNEB Limited for an amount of Rs.98/- plus applicable GST per month per SIM Card for unlimited voice calls with free roaming all over India to all the mobiles and landlines with 2G/3G/4G Technology with free bandwidth of data and 100 SMS per day, with effect from 01.09.2019.

2. Now, the BLTC after careful consideration, has approved the proposal of re-fixing the monthly ceiling limit in respect of mobile call charges to all the officers of TANGEDCO and TANTRANSCO for an amount of Rs.98.50/- plus applicable GST per month per SIM Card for unlimited voice calls with free roaming all over India to all the mobiles and landlines with 2G/3G/4G technology with free bandwidth of 30 GB data per month and 100 SMS per day. This new plan will come into effect, from 01.01.2023.

3. Based on the approval of the BLTC, the Chief Engineer, Protection & Communication has issued a detailed Purchase Orders to the concerned companies in his Purchase Orders 3rd read above. Further he has requested to issue a fresh B.P. based on Purchase Orders issued by him.

4. The proposal of the Chief Engineer, Protection & Communication has been examined in detail and decided to accept the same based on the approval obtained in the BLTC. Accordingly, it is hereby ordered that ceiling limits on each mobile phones network charges be re-fixed to Rs.98.50/- plus GST per SIM Card. The ceiling limit fixed above should be strictly followed and excess expenditure in this regard shall be brought before the Chairman cum Managing Director/TANGEDCO for approval.

5. The expenditure towards payment of network charges on each mobile phone debitable to the Head of Account No.76.111.

6. The receipt of the Proceeding shall be acknowledged.


