Sub: Loans and Advances – Motor Vehicle Advances to the Employees of TANGEDCO, TANTRANSCO and TNEB Limited inclusion of Electric Vehicles (e-vehicles) for the purpose of sanctioning Motor Conveyance advance – Orders – Issued.

On the basis of the modern tendency some of the Government employees demanded for purchase of e-vehicles and has ordered that the Electric Vehicles (e-vehicles) shall be included under motor vehicles category for the purpose of sanctioning motor conveyance advance to Government employees.

It has been decided to include the Electric Vehicles (e-vehicles) under motor vehicles category for the purpose of sanctioning conveyance advance to the employees of TANGEDCO, TANTRANSCO and TNEB Limited. Hence, necessary proposal has been placed before the Board Meeting of TANGEDCO in its Meeting held on 19.11.2022. The Board of TANGEDCO has approved the same.
