#### **PROCEEDINGS:**

The Government of India have ordered that grant of 27% reservation to OBCs is subject to exclusion of creamy layer among them based on the criteria prescribed in the Schedule appended to the Office Memorandum first read above. Category II(C) of the Schedule for exclusion of creamy layer relating to children of employees of Public Sector Undertakings requires that the posts in Public Sector Undertakings equivalent or comparable to the Group A or B posts of the Government Departments, are to be determined for similar application of the creamy layer exclusion criteria as in Category II(A) or II(B) meant for the children of Group A or B employees of the Government Departments belonging to Other Backward Communities (OBC).

2. Considering the difficulties experienced by the children of employees working in the TNEB Ltd., TANGEDCO and TANTRANSCO in availing the benefits of OBCs (Other Backward Communities) reservation under the Government of India, the Government in its G.O. second read above, have issued orders for determination of posts in the TNEB Ltd., TANGEDCO and TANTRANSCO which are equivalent or comparable to the posts classified as Group A, B, C or D in the Government Departments, for the purpose of creamy layer exclusion criteria prescribed by the Government of India. Hence, a proposal for adoption of the said Government Order in TANGEDCO, has been placed before the Board of TANGEDCO for its approval. After careful consideration, the Board of TANGEDCO has approved the said proposal.

<u>3.</u> Accordingly, it is hereby ordered that for the purpose of exclusion of creamy layer among OBCs in CATEGORY II(C) of the Schedule appended to the Office Memorandum first read above, the posts of TNEB/TANGEDCO/TANTRANSCO having scales of pay under Class I, II, III and IV Services as stated below, are equivalent or comparable to the posts with scales of pay under Group A, B, C and D of the Government departments respectively:

(TANGEDCO) and Tamil Nadu Transmission Corporation Ltd.
(TRNTRANSCO) on the basis of pay scales as Class I, II, III or IV:
