Sub: TANGEDCO – Establishment – Incentive increment for having passed B.Com/M.Com through Open University - Sanctioned – Audit Objection – Clarification - Issued.

In the Board's Proceedings third cited, orders were issued to the effect that a Diploma, Degree or Post Graduate Degree after a pass in SSLC(10th Std), HSC (+2), Basic Degree only be considered for appointment/ promotion in the services of the TANGEDCO by adopting the Government orders first and second cited.

2. In the Board's Proceedings fourth cited, among other things orders were issued that for the purpose of promotion to the employees in Accounts Branch and Audit Branch, the relevant service regulation on the date of crucial date prescribing passing of B.com or M.Com or both as the case may be, either through formal system or through Open University should be applied only for the limited purpose of exemption from passing departmental exam.

3. A point of clarification has been arisen by the Chief Engineers/ Superintending Engineers whether the employees who have obtained B.Com/M.Com degree through open university without passing 10th,+2 and promoted as Accounts Supervisors from the post of Assistant (Accounts) based on the orders issued in (Per.) B.P CMD Proceedings No.59, (Adm.Br.) dated: 24.05.2013 are eligible for sanction of advance increments.

4. After careful examination, it is clarified that the employees who have obtained B.Com/M.Com degree through open university without passing 10th,+2 and promoted as Accounts Supervisors from the post of Assistant (Accounts) based on the orders issued in (Per.) B.P CMD Proceedings No.59, (Adm.Br.) dated: 24.05.2013, are not eligible for sanction of advance increments.


