PROCEEDINGS:-

In the Proceedings read above, temporary promotion was given to 17 individuals (1CHD + 12AEs + 4JEs) to fill up the vacancies of AEE/Electrical due to administrative exigencies. At present there are so many vacancies in the post of Assistant Executive Engineer/Electrical and the preparation of panel for the above said post is under process and it will take some more time to approve the panel. Hence, it has been decided to fill up the vacancies with the fully qualified candidates and to give temporary promotion to the fully qualified candidates in the cadre of Assistant Engineer/ Electrical and Junior Engineer/ Electrical I Grade.
