PROCEEDINGS:

The TANGEDCO has decided to fill up the vacancies in certain categories through direct recruitment. Hence, Notifications have been issued for calling application from the eligible candidates. The details are as follows :

Based on the above notifications, applications have been received from the eligible candidates through open market and employment exchange.

- 2) In the proceedings 5th read above, C-DAC (Center for Development of Advanced Computing) was nominated for conducting CBT (Computer Based Test) for Direct Recruitment of the above said posts in TANGEDCO. The exams for the post of Assistant Engineer and Junior Assistant (Accounts) which was tentatively scheduled to be conducted during the month of April/May 2021 was postponed due to pandemic Covid 19 crisis and the scheduled Tamil Nadu State Assembly Election.
- 3) The Government of Tamil Nadu in the meantime have enacted the Tamil Nadu Public Service Commission (Additional Functions) Act, 2022 (Tamil Nadu Act No.14 of 2022) on 31.01.2022. The said Act has been published in G.O. (Ms) No.30, HRM (M), dated 17.03.2022 and notified in Part II- Section 2 of the Gazette of Tamil Nadu, the said Tamil Nadu Act No.14 of 2022 came into force from 17.03.2022. Section 3 of the said Act read as follows:

"Notwithstanding anything contained in any State law for the time being in force, any organization may request the Commission, in such form as may be prescribed, to recruit candidates for appointment to posts in that organization".

Further, Section 2 (c) provides that "organization" means a State owned Public Sector Undertaking, State Corporation, or a statutory Board or Authority under the control of the Government.

4) Based on the above Act passed by the Government of Tamil Nadu and as on date the said Act is in force, any further process of the earlier Notification Nos.1, 3, 4 and 5 of 2020 and Notification No.1 of 2021 at this distance of time is not viable. Hence, it has been decided to cancel the above said notifications and to cancel the orders issued to M/s C-DAC for conducting the examinations and to refund the fees collected from the applicants as per the above notifications.

5) Accordingly, the Notification Nos. 1, 3, 4 and 5 of 2020 and Notification No.1 of 2021 issued for filling up of posts mentioned in para (1) above, is hereby cancelled and the orders issued in the proceedings 5th read above nominating M/s. C-DAC to conduct Computer Based Test is also hereby cancelled and the application fee collected from the applicants will be refunded to them.

The method of refunding the applicants fees will be issued separately.
