### **PROCEEDINGS:-**

The orders issued in the proceedings third read above is hereby cancelled.

2. In the proceedings first read above, orders were issued communicating certain changes in the delegation of powers of sanction to Officers in (TNEB Manual Volume-II). In the said proceedings, orders have been issued among others to delegate the powers of the Chairman and the Chief Engineer for sanction of the funds under Item No.25 Miscellaneous. The details are as follows :-

### **Item No.25 Miscellaneous:**

Sl. No.	Authority	Powers (in Rs.)
1.	Chairman	Full Powers
2.	Chief Engineer	Rs.5000/- each subject to a maximum of Rs.25,000/- per annum. Note : The powers are subject to the condition that there is specific budget appropriation made for the purpose and that the expenditure is non recurring.

3. The Chief Engineer/Planning & Resource Centre has proposed to include an item of "Preparation of various meeting booklets by outsourcing which involves multiple printing, photo copying, binding works etc." with delegation of sanctioning powers to the Chief Engineers/Headquarters upto Rs.3.00 lakhs per annum, as the existing powers under item No.25 are not adequate due to the escalation in material cost, technology development, increase in labour charges and introduction of GST. Hence, necessary proposal has been placed before the Board Meeting of TANGEDCO.

4. In its Board Meeting held on 07.06.2022, the Board of TANGEDCO has approved the above proposal. Accordingly, the following amendment be issued to the (Per) FB TANGEDCO Proceedings No.71, Tech. Br. dated 29.06.2011 by including the item approved by the Board :-
