Memorandum (Per.) No.39468/A17/A171/2020- 4, dated 18.07.2022.

Sub: Establishment – Additional charge arrangements in Thermal Power Stations – Measures on curtailing expenditure – Certain instructions issued – Sanction of Additional Charge Allowance - Objections raised by the Audit Parties – Instructions – Issued.

In continuation of the clarificatory orders issued in the reference second cited and in supersession of the orders issued in the reference third cited, the following instructions are issued to all the Competent Authorities:

(i) In Thermal Power Stations, Additional Pay (Additional Charge Allowance) shall be granted to the officials holding Additional Charge of the posts of Assistant Engineers/Assistant Executive Engineers/ Senior Chemists in the following Divisions/Wing which are having different territorial jurisdictions and definitely independent:

"Technical services, Boiler Maintenance, Turbine Maintenance, Mill Plant Maintenance, Common Auxiliaries, Coal Handling & Fire Fighting, Ash Handling Plant, Electrical Maintenance—I, Electrical Maintenance—II, Control & Instrumentation, Meters & Relays Testing, Civil Maintenance—I, Civil Maintenance—II and Central Maintenance Planning (except those in Environment Monitoring & Training Sub-Divisions); and Chemical Wing (except those are in shift duties)";

- (ii) The objections raised by the Audit Parties on the Additional Charge arrangements made to the posts as stated in clause (i) above, shall be dropped;
- (iii) The Recovery Proceedings initiated against the Additional Charge allowances paid to the officials in Thermal Power Stations shall be dropped and the amount recovered from them, shall be released;
- (iv) The pending bills of the Allowances for Additional charge Arrangements made already in the posts of AE/AEEs shall be processed.

- **2**. While sanctioning the Additional Charge Allowance to the officials in Thermal Power Stations, the Chief Engineers of Thermal Power Stations shall certify that the responsibilities of the officials in the Additional Posts are not divisible and both the regular and additional posts are in different territorial jurisdiction.
 - <u>3</u>. The receipt of the Memorandum shall be acknowledged.
