In the Government Order first cited, Government have taken a decision to sanction of lumpsum incentive to the employees of Tamil Nadu Government for acquiring higher educational qualification with effect from 10.03.2020.

In the Government letter third cited, it has been instructed that the orders issued in Government Order first cited regarding sanction of lumpsum incentive need not be adopted to the employees of State Public Sector Undertakings/Statutory Boards and the above fact may be brought to the notice of the Board of Directors.

3. The above Government letter has been placed before the Board of TANGEDCO for adoption. The Board of TANGEDCO has accepted the proposal. Accordingly, the TANGEDCO hereby ordered that the scheme of grant of lumpsum incentive to the Government employees for acquiring higher qualification shall not be extended to the employees of TANGEDCO.
