**PROCEEDINGS:**

The proposal for conducting internal selection by following the existing procedure until a policy decision has to be taken was placed before the Board of TANGEDCO considering the huge number of vacancies in the initial level categories. The TANGEDCO in its 107<sup>th</sup> Board Meeting held on 07.06.2022 has directed as follows:-

- i. *"Henceforth internal selection shall not be allowed for new recruits and persons acquiring qualification from this date. The cut-off date for implementation of this policy shall be from 07.06.2022. Internal selection shall be considered for existing staff who have already acquired the qualification as per provisions of Service Regulations.*
- ii. *Further, qualifications obtained through Open Universities/Correspondence Courses without studying 10<sup>th</sup>, +2 under regular stream as notified by the UGC, shall not be considered for appointment through internal selection".*

2) Accordingly, it is hereby ordered that the internal selection shall be allowed to continue with the existing eligible employees who have already acquired the qualification prior to 07.06.2022 only as per provisions of Service Regulations. Further, with regard to the amendment issued to Service Regulations No.94 vide (Per.) FB TANGEDCO Proceedings No.3 (Secretariat Branch) Dated: 09.01.2015 it is also ordered that the qualifications obtained through Open Universities/ Correspondence Courses without studying 10<sup>th</sup>, +2 under regular stream as notified by the UGC, will not be considered for appointment through internal selection".
