TANGEDCO – Age of Superannuation of employees - Increased from 58 years to 60 years – Amendments to regulation 17 of Tamil Nadu Electricity Board Service Regulations – Orders - Issued.

PROCEEDINGS:

In the G.O. first read above, orders had been issued by the Government, increasing the age of superannuation of Government servants from 58 years to 59 years. In the G.O. fourth read above, necessary amendments to this effect have been issued to rule 56(1) of the Fundamental Rules. By adopting the G.O. first read above, orders were issued increasing the age of superannuation of the officials in Officers categories (Class-I & II services) and Workmen categories (Class-III & IV services) from 58 to 59 years respectively – vide proceedings second and third read above.

2. In the G.O. fifth read above, orders had been issued by the Government, increasing the age of superannuation of Government servants from 59 years to 60 years. In the G.O. seventh read above, necessary amendments to this effect have been issued to rule 56(1) of the Fundamental Rules. By adopting the G.O. fifth read above, orders were issued increasing the age of superannuation of the officers/ employees of TANGEDCO from 59 years to 60 years – vide Proceedings sixth read above.

3. The Tamil Nadu Electricity Board Service Regulations have been framed based on the Tamil Nadu State and Subordinate Services Rules (repealed as Tamil Nadu Government Servants (Conditions of Services) Act, 2016) and the Fundamental Rules of Government of Tamil Nadu. Regulations is corresponding to rule 56 of the Fundamental Rules. Hence, a proposal for making amendments to the said regulation based on the orders issued by the Government in its G.O. seventh read above, has been considered and approved by the Board of TANGEDCO.

4. Accordingly, in exercise of the powers conferred by Section 79(c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), read with Section 185 of the Electricity (Supply) Act, 2003 and G.O.Ms.No.100, Energy (B2) Department, dated 19.10.2010, the Tamil Nadu Generation and Distribution Corporation Limited (formerly Tamil Nadu Electricity Board) makes the following amendments to the Tamil Nadu Electricity Board Service Regulations:-

AMENDMENTS

In the said Regulations, in regulation 17,

I. for Clause (a), the following Clause shall be substituted:

"(a) Every employee in the superior as well as basic service shall retire from service on the afternoon of the last day of the month in which he attains the age of sixty years. He shall not be retained in service after that age.

Explanation.— When an employee is required to retire, revert or cease to be on leave on attaining a specific age, the day on which he attains that age is reckoned as a non-working day and the employee shall retire, revert or cease to be on leave, with effect on and from that day."

II. Clauses (b), (c), (d) and (e) shall be omitted;

5. The above amendments shall be deemed to have come into force from 25.02.2021.
