Sub: TANGEDCO – Departmental Test for Accounts Officers passed by Typist, Steno Typist, Junior Assistant and Assistant – Not eligible for sanction of advance incentive increment – Clarification –Issued.

In the reference first cited, among other things orders have been issued for sanction of one advance incentive increment to Accountants (now Accounts Supervisor) who have passed Departmental Test for Accounts Officers.

2. In the reference second cited, orders have been issued to cancel/dispense with the scheme of sanction of advance increment for passing Departmental Tests to the Administrative, Accounts, Audit, Stores and Technical categories with immediate effect i.e., 28.05.2020.

3. A point of clarification has arisen by the Chief Engineers/ Superintending Engineers whether the employees who are working as Typist, Steno Typist, Junior Assistant and Assistant and passed Departmental Test for Accounts Officers before 28.05.2020 are eligible for sanction of advance incentive increment for passing the above departmental test frequently.

4. After careful examination, it is hereby clarified that the employees while working as Typist, Steno Typist, Junior Assistant and Assistant, passed Departmental Test for Accounts Officers even before 28.05.2020, are not eligible for sanction of advance incentive increment for passing the above departmental test, since the advance incentive increment is entitled in the post of Accounts Supervisor only. Hence, those who have promoted to the post of Accounts Supervisor prior to 28.05.2020 and passed the Departmental Test for Accounts Officers alone is eligible to get advance increment.
