PROCEEDINGS:-

In the proceedings read above, the panel for the post of Assistant Executive Engineer/Electrical consisting of 385 candidates for the year 2019-2020 was approved. The panel has been exhausted. At present there are so many vacancies in the post of Assistant Executive Engineer/Electrical and the preparation of panel for the above said post is under process and it will take some more time to approve the panel. Hence, it has been decided to fill up the vacancies with the fully eligible candidates and to give temporary promotion to the fully qualified candidates in the cadre of Assistant Engineer/Electrical, Junior Engineer/ Electrical I Grade and Chief Head Draughtsman. Accordingly, the following 17 candidates (1 CHD + 4 JEs I Grade + 12 AEs) be temporarily promoted as Assistant Executive Engineer/Electrical under Regulation 106 of TNEB Service Regulations and allotted to the circles mentioned against their names with effect from the date of assumption of charge of the officers.
