Sir/Madam,

Sub: Recruitment – Class III Service - Filling up of Vacancies of Junior Engineer/Electrical II Grade – Appointment by transfer method against reserved vacancies for the employees in RWE categories (Non-Diploma Holders) – Proposals -Called for.

It is proposed to call for application from the qualified RWE employees for appointment to the post of Junior Engineer/Electrical II Grade against the fourth vacancies reserved to be filled by RWE employees of Non-Diploma holders as per provisions in Service Regulation and as (Per) B.P.(FB) No.17 dated 05.07.2003. The employees working as Line Inspector or on equivalent post or higher posts in the RWE cadre, who possess a minimum educational qualification of "a completed SSLC" or one who has passed SSLC by private and who has possess not less than 6 years of practical experience in Electrical side in the Board and who has adequate knowledge in Tamil (i.e. Attended Tamil Language in a completed SSLC or pass in Tamil Language in SSLC studied by Private or medium of study is Tamil or Passed Tamil Language Test) are eligible to be considered for appointment as Junior Engineer/Electrical II Grade.

2) I am, therefore, to request you to send your proposals on the following lines:-

- (i) To furnish the applications of RWE employees (Non-Diploma) working as Line Inspector or in equivalent posts and in higher categories, based on Community wise upto the years as mentioned below duly furnishing the

particulars of such RWE employees as required in the Annexure to this office under reference letter.

- (ii) To furnish the correct date of first appointment and also date of Joining as L.I. or equivalent posts for the RWE employees. The experience in Electrical side is a must and hence only those who are having practical experience in Electrical field alone should be recommended for selection.
- (iii) To obtain the applications from the employees certificates towards evidence of their Date of Birth, Community, SSLC Qualification (SSLC Marks Sheet & SSLC First Page) and a certificate for Physically challenged person if any, by fixing a last date for receipt of application and on forwarding of application, necessary genuineness certificate has to be obtained from the concerned Educational Department for the SSLC Qualification as stipulated in Memo. No.68638/A18/A18/2019-1 (BOBS) dated 04.02.2020 as the probation may be declared there in.
- (iv) To furnish bio-data of employees in their applications may be thoroughly verified with reference to Service Book and a statement furnishing the names of employees applied for the post of Junior Engineer/ Electrical II Grade may be prepared as Annexure-A (Specimen form enclosed) and the statement may be sent along with the certificates submitted by the employees.
- (v) In case, Disciplinary Proceedings are pending against any of the employee the nature of charges on which D.P. has been initiated the stage at which the D.P. is pending may be indicated and whether the employee is any undergoing punishment, the nature of proved charges, kind of punishment imposed and the date of commencement and the probable date of completion of punishment may also be furnished.
- (vi) The selection will be made on merit according to the rule of reservation order as per G.O.Ms.No.65, P & AR (K) Department dt.27.05.2009.

(vii) In order to avoid inordinate delay and to expedite the process the Superintending Engineer's are requested to obtain the proposals from eligible employees by giving wide publicity in the field and displaying the call for in Notice Board and obtain applications from the eligible employees on or before 10.06.2022 Further the Superintending Engineer's are informed that, any application received beyond the stipulated period need not be taken into consideration and the same may be returned to the individual with proper reasoning and the said action has to be intimated to this office without fail. Further the Superintending Engineer's may consolidate the report and send the entire proposals etc., to this office on or **before 20.06.2022**. Any applications received beyond that date from the Superintending Engineer's concerned will not be considered for examination and the erring officials/staffs will be held responsible for the delay and suitable actions deemed fit will be taken in this regard.

3) I am to request you to forward the consolidated proposal furnishing all the required details in complete shape, in Annexure-A so as to reach this office positively **before 20.06.2022** without fail.

4) If no qualified person is available, a NIL report should be sent on or **before 20.06.2022**. I am to request you to acknowledge receipt of this letter.
