In the references first to sixth cited, orders have been issued as amended from time to time to honour the retiring employees of TNEB by adorning with a shawl and issue of a “Commendation Certificate” on the last day of the month in an official function.

2. Orders were issued in the reference seventh cited on presentation of “Crest” as Memento in addition to Commendation Certificate and Shawl for retiring employees of Tamil Nadu Electricity Board at a cost not exceeding Rs.130/- per piece.

3. Subsequently, in the reference eighth cited, orders were issued that the cost fixed for the purchase of memento “Crest” be enhanced from Rs.130/- to Rs.200/- per piece. Also, approval was accorded for printing all three symbols (viz) TNEB Ltd., TANGEDCO and TANTRANSCO in the Memento “Crest” as printed in the calendar.

4. Now, it has been proposed to enhance the ceiling limit of purchase of Memento from Rs.200/- to Rs.500/- and it has been decided to accept the same. Accordingly, it is hereby ordered that the cost fixed for the purchase of memento "Crest" be enhanced from Rs.200/- to Rs.500/- (Rupees five hundred only) per piece, which includes printing of all three symbols of TNEB Ltd., TANGEDCO and TANTRANSCO, name of the employee, his/her photo, Designation, Date of Joining and Date of Retirement.
