ABSTRACT**

TANTRANSCO –Transmission Projects and System Operation/Chennai-Proposal for formation of 1 no. new Hotline division along with 1 no. new special hotline vehicle at Korattur and additional staff strength to each existing Hot line section by redeployment of posts instead of creation of new posts- Administrative Approval- Accorded.

PROCEEDINGS:

Initially, Hotline wing was established in the erstwhile TNEB with the objective of attending EHT line maintenance works by the workmen without interrupting the EHT supply. One number Hot line subdivision was formed and it was headquartered at Chennai. Then, Hot line subdivisions were formed in Coimbatore, Thiruvallam, Madurai and Trichy in a phased manner due to the importance of the Hot line works.

However, the hot line works are taken up by pooling the trained staff by temporary diversion of the trained staff from various TANGEDCO/TANTRANSCO sections for the stipulated period of hot line camp program. During emergency, pooling of trained staff had become tedious and hotline works were getting delayed due to non-availability of the staff since the Hotline trained staff are working in various distribution section offices of TANGEDCO and certain trained staff are also working in EHT Substations and EHV lines sections of TANTRANSCO.

Further, it has been announced in the Tamil Nadu Legislative Assembly by the Honorable Minister for Electricity, Prohibition & Excise that 1 no. Hotline division will be formed.

Due to higher load flow in Chennai city, frequent hotspots are developing at the EHV sub stations and it needs to be attended without interruption by Hotline wing. Moreover, 5990 MW of power is being evacuated from generating stations based at Chennai through Chennai city transmission networks.

Considering importance of Chennai city hotline works and for better functioning of the Hotlines wing in the Chennai it has been proposed to form one Hotline division at Korattur.

In pursuance of the above, approval is hereby accorded for the following.

1. Formation of 1 no. Executive Engineer/Hotline division, headquarters at Korattur by combining the posts of Executive Engineer/Operation/CMRL Koyambedu SS and Executive Engineer/Operation/Koyambedu 230 kV SS into 1 no. Executive Engineer/Operation post and the post may be redeployed and re-designated as Executive Engineer/Hotline/Korattur. Posting on promotion of Thiru.R.Kasi, AEE/GIS/Korattur on the above post of Executive Engineer/Hotline/Korattur in the newly formed Hotline Division based on the announcement in the Tamil Nadu Legislative Assembly on 26.04.2022 by the Hon'ble Minister of Electricity, Prohibition and Excise.
2. Additional staff strength to each existing Hot line section by redeployment of posts instead of creation of new posts.
3. Provision of 1 no. new special Hotline vehicle for Hotline division at Korattur and hiring vehicle to the 3 Hotlines sections (Coimbatore, Madurai and Thiruvalam) for carrying out inspection of Hotline works.
4. For revision of safety amenities and issue of accident policy insurance for the Hot Line Trained Officers and Staff.
